Modifications to Cotton Loan Software Systems for Upland Cotton Fine Count Adjustment and 10 Percent Maximum Storage-Credit Rate Reduction

1 Overview

A Background

The Food, Conservation, and Energy Act of 2008 (2008 Act) provides:

- that the warehouse storage rates to be used for calculating storage credits applicable to upland cotton loan repayment amounts shall be the storage-credit rate applicable to the 2006 crop, reduced as follows:
 - for 2008 through 2011 crop loan redemptions, reduce the maximum storage-credit rates used for the 2006 crop by 10 percent
 - for 2012 and subsequent crop repayments, reduce the maximum storage-credit rates used for the 2006 crop by 20 percent
- for applying a fine count adjustment to upland cotton loan repayment amount calculations.

B Purpose

This notice announces that, effective with upland cotton loan redemptions calculated starting August 28, 2009, the:

- 10 percent reduction of the maximum storage-credit rates will be implemented in **all** cotton software systems for upland cotton redemption calculations
- fine count adjustments will be implemented in APSS loan redemption calculations; the fine count adjustment has previously been incorporated into ACRS used by CMA's and LSA's, and into the web-based redemption processes used by merchants.

Note: Software to implement these changes in the System 36 will be broadcast August 27, 2009, and contained in County Release No. 675 scheduled for early September 2009.

2 Reducing Storage-Credit Maximum Rates

A ACRS and APSS Modifications

Effective for transactions processed starting August 28, 2009, ACRS and APSS shall both be modified to calculate storage credits as the lower of the following:

- public tariff storage rate for the crop year submitted by the warehouse where stored
- storage-credit rate applicable to the 2006 crop, reduced as follows:
 - for the period starting August 28, 2009, and ending with the 2011 crop repayments, the maximum storage-credit rates used for the 2006 crop reduced by 10 percent
 - for 2012 and subsequent crop repayments, the maximum storage-credit rates used for the 2006 crop reduced by 20 percent.

B Maximum Storage-Credit Rates

The maximum storage-credit rates are shown in the following table.

Note: For any cotton storage warehouse that does **not** have a storage-credit rate established for the 2006 crop, DACO staff will provide a rate to be used.
