Dear Chairman Wyden:

On behalf of partnerships from across the United States' economy, the undersigned organizations write to express our opposition to the proposed changes to Subchapter K of the Internal Revenue Code included in the *Pass-through Reform Discussion Draft* released on September 10, 2021. If enacted in its current form, the discussion draft would act as a drag on the U.S. economy by creating uncertainty and complexity for millions of businesses in America.

As you know, the partnership structure is a longstanding construct used by individuals, companies and research institutions to pool capital resources with expertise to provide goods and services demanded by the market. Partnerships are so common and integrated into our economy that any disruption to their function, or increased administrative or tax burdens, have an immediate and widespread negative impact on the U.S economy. They are flexible arrangements that allow taxpayers to bring resources together in ways that maximize synergies to best compete in the modern economy.

Given the broad consequences of changes to partnership rules, we oppose inclusion of this proposal in the Build Back Better Act. It is imperative that any changes to the tax rules governing these businesses be approached in a deliberative manner that provides the opportunity for input from affected entities and robust, public debate at the Committee. There are more than 4 million partnerships with over 27 million participating partners in the U.S. These firms are currently facing ongoing challenges as the nation recovers from the pandemic, including supply chain disruptions, rising costs and labor shortages – now is a particularly perilous time to alter tax rules for such a wide swath of the economy.

In addition, the Internal Revenue Service has finalized rules implementing augmented enforcement and audit authority it was granted by Congress in the Bipartisan Budget Act of 2015. The IRS and the Department of the Treasury have signaled that they will begin issuing audit notices under its "Large Partnership Compliance Program" this fall. By focusing on the largest and most complex partnerships, the agency is already taking action against potential abuses of Subchapter K rules. Furthermore, in anticipation of this initiative, the IRS added more than 200 new agents to its Large Business and International Division, and are devoting "significant resources to its Global High-Wealth Program and has committed to identifying high-income non-filers," according to a analysis from KPMG LLP.¹ Accordingly, we believe that more time is needed to determine the efficacy of IRS implementation of the most recent Congressional action on Subchapter K.

The undersigned organizations on this list fully support fair and equitable enforcement of our nation's tax laws. Consistency of policy and the enforcement is fundamental to creating a durable investment environment that allows businesses large and small to start, grow, expand and create jobs that improve lives. The long-standing rules that govern partnerships are among the most foundational policies that have allowed our economy to be the most dynamic in the

world. Therefore, changes to those rules cannot be undertaken lightly without running the risk of causing significant unplanned economic disruption. Consequently, we encourage you to exclude the proposed changes to Subchapter K in the final version of the reconciliation package.
