














118th US Senate makeup







Background

Former CEO of the Business Council of Alabama and congressional chief of staff ran to replace her previous boss in the US Senate; campained on a platform of conservative and business values

Born and raised in Alabama, Britt is a daughter of small business owners in the Wiregrass region of Alabama

After serving as the youngest press secretary on Capitol Hill at the time, Britt rose through the ranks of Sen. Richard Shelby (R-AL)'s office; notably, while working for Shelby as chief of staff, she led efforts during the selections of Alabama court judges and Supreme Court justice confirmation hearings of Neil Gorsuch and Brett Kavanaugh

A lawyer and CEO of the Business Council of Alabama (BCA), a nonpartisan business association, Britt has experience communicating business interests with elected officials; propelled the state's businesses through the COVID-19 pandemic, advocating for Alabama to reopen and to learn about federal stimulus funding

Prioritizes centering Alabama in state, federal, and international policies, especially in foreign trade, national security, broadband access, and low-cost energy sources

In 2021, Britt stepped announced her bid to be the next Senator for Alabama with the endorsement of Sen. Shelby and emerged as a top contender for the nomination--ahead of the primary she lead the field in fundraising, received financial support from Senate Republicans, and won key state-level endorsements

In May 2022, Britt won the largest share of votes in the primary, but failed to capture a majority; prior to the June runoff against Rep. Mo Brooks (R-AL5), Britt received former President Trump's endorsement and later defeated Brooks in the runoff

Background

Longtime public official who has consistently focused on cutting taxes; became attorney general in Missouri in 2019, and worked to advance a number of conservative priorities before launching his campaign for Senate

After graduating from law school, Schmitt worked in Clayton, Missouri as an attorney; successfully campaigned to be an alderman of Glendale, Missouri in 2005 and served in the local office until 2008

Joined the Missouri state Senate in 2009; led the bipartisan effort to ban traffic ticket quotas and limit fine revenue, after a traffic stop led to a deadly shooting in Ferguson, Missouri in 2014 amid racial justice protests

Led major state tax policy reforms, which included cuts to taxes on franchises, corporations, and incomes; created automatic tax cuts that triggered when revenues rose

After reaching the Senate senate term limit, Schmitt ran for Missouri state treasurer where he continued pursuing tax cuts; in 2018, Schmitt championed efforts to create the state's "Show-Me Checkbook," a website detailing state revenues and expenditures

Appointed to attorney general in 2019, filling a vacancy left by newly-elected Sen. Josh Hawley (R-MO), and was elected to a full term in 2020; his tenure as attorney general has focused on advancing GOP priorities through legal challenges, such as seeking to invalidate the Affordable Care Act (ACA), to limit COVID-19 public health measures, to expand oil and gas projects, to prohibit the expansion of LGBTQ+ rights, and to overturn the 2020 presidential election results

Ran for Senate in 2022 to fill a vacancy left by Sen. Roy Blunt (R-MO); prevailed with 44% of the vote in a contested primary against two current members of Congress and fmr. Gov. Eric Greitens (R)



Elected in 2016 as a first-time political figure, Budd prioritizes deregulating the financial sector and improving health care; in 2022, he ran on his conservative record in the race for North Carolina's open Senate seat

Grew up on a cattle and commercial chicken farm in Davie County, North Carolina, where he still lives with his wife

After receiving a graduate degree from Dallas Theological Seminary and completing a mission trip to the former Soviet Union, he worked for his father's facility services company, The Budd Group; currently owns and operates ProShots, a gun store, and shooting range

Elected in 2016, Budd gained support in the primary race as an outsider with conservative values; backed by conservative organizations such as Club for Growth, which invested \$500,000 in his TV advertisements

Serves on the Financial Services Committee, where he uses his business administration background to advocate against overregulation; he is also a strong opponent of the ACA

Voted in Congress on January 6, 2021, to object to the certification of Electoral College results from Pennsylvania and Arizona affirming President Joe Biden's election

Announced in 2021 a bid for North Carolina Senate to replace retiring Sen. Richard Burr (R); ran on a message of combatting the "liberal agenda" with the endorsement of former President Trump

Handily won the May 2022 Republican primary and faced former North Carolina Supreme Court Justice Cheri Beasley (D) in the general election

Ran for Congress after the retirement of his predecessor, Rep. Dan Boren (D-OK2); highlighted his outsider status as a local businessman during the campaign

Mullin sits on the Energy and Commerce Committee's Health, Environment, and Climate Change and Communications and Technology subcommittees and tailors his legislation to address these issues in Oklahoma; also serves on the Committee on Intelligence and several of its subcommittees

Has worked on bills to give Native American tribes access to grant programs to combat opioid addiction, awarded grants to rural electric cooperatives to better utilize renewable energy, and established an FCC program to promote rural broadband networks

Voted in Congress on January 6, 2021 to object to the certification of Electoral College results affirming President Joe Biden's election

Following Sen. Jim Inhofe's (R-OK) retirement announcement, Mullin declared his candidacy to replace him, citing a need to represent "America First" perspectives in the Senate

Focused his 2022 campaign on salient economic issues, such as inflation, government spending, and gas prices, and social issues such as election integrity, immigration, abortion, gun rights, and transgender students' participation in school sports; won Oklahoma's primary runoff election in August 2022

Born and raised in Monrovia, Alabama, Strong worked at his father's gas and grocery shop before going to school; his father started a bus services business to take people on trips throughout the country, which allowed Dale and his two siblings afford college

Received his license as an emergency medical technician (EMT) from the University of Alabama-Huntsville and worked for Huntsville Emergency Medical Services as an emergency dispatcher and first responder

In 1989, Strong recieved the Medal of Valor for his actions during the tornado on Airport Road in Huntsville, which destroyed dozens of homes and businesses

In 1992, Strong graduated from Athens State University and began his professional career working in public relations at First Alabama Bank and later as a sales representative with Solvay Pharmaceuticals

Elected to serve as a county commissioner in 1996, Strong established new baseball fields, community centers, tornado sirens, and safer intersections; also led recovery efforts in the aftermath of the 2011 Super Tornado, one of Alabama's largest and deadliest tornado outbreaks

In 2012, Strong was the first Republican elected to be the chair of the Madison County Commission; his fiscally conservative campaign focused on limited government spending and Christian values

As chair, Strong encouraged Facebook and Toyota to open projects in Alabama and continued to serve as a volunteer firefighter and EMT in Monrovia

Announced in March 2021 that he would campaign for a House seat in the 2022 election cycle; Strong's campaign focused on fiscal conservatism and immigration

Won the Republican primary runoff election with 62.8% of the vote and easily secured victory in the solidly Republican district in the general election



Beginning with his stint in Heinrich's office, Vasquez's environmental advocacy career continued through his roles in several wilderness and environmental conservation advocacy groups; worked with state legislators to enact the New Mexico Outdoor Equity Fund to provide outdoor opportunities to underserved youth, and collaborated with other groups to launch a similar initiative on the federal level

Elected to the Las Cruces City Council in 2017, and served for four years; during his tenure, he pushed for infrastructure and parks investments, marijuana legalization, and payday loan reform

Announced his bid for Congress in September 2021, aiming to unseat incumbent Rep. Yvette Herrell (R-NM2); won the Democratic primary in June 2022 with 76.1% of the vote

Campaigned on a progressive platform of climate change, conservation, economic development, and immigration reform; highlighted his experience in advocacy, Vasquez aimed to ensure his proposed policies include the perspectives of marginalized groups



Shifting to a career in law, Nickel worked in a district attorney's office and later a private law firm in California; first ran for office in 2006, but lost in the general election for California's 12th Senate District

In 2008, Nickel joined the national advance staff of presidential candidate Barack Obama and returned to serving in the White House for the first term of the Obama administration

In 2011, Nickel and his wife, Caroline, decided to move closer to where Caroline was from in North Carolina; started his own criminal defense law practice in Cary, where Nickel and his wife have been raising two children

Returning to a career in politics, Nickel successfully ran for state Senate in 2018, when Democrats ended the Republican supermajority in the General Assembly; as a state Senator, Nickel has represented parts of Wake County and has prioritized redistricting and voting reform, criminal justice reform, clean energy, and extending unemployment benefits and Medicaid coverage

In October 2021, Nickel decided that he would campaign for a House seat; announced his candidacy for North Carolina's open 13th District in February 2022

Optimistic that the competitiveness of North Carolina's 13th District would communicate the message that "your vote will mean something" to constituents, Nickel focused his campaign on the economy, voting access, and reproductive rights

Proposed several social policy-focused bills in the state legislature, targeting reproductive rights, gun control, and LGBTQ+ rights; retired from the state Senate in 2018 and opened an excavation and trucking business

Returned to politics in 2022, campaigned to fill the vacancy left by Rep. Markwayne Mullin (R-OK), who retired to run for Senate, on a platform of states' rights, abortion restrictions, and reduced government spending

Won the 2022 primary in a close runoff election, prevailing by 4% of the vote; placed second in the original 14-way primary as one of five candidates receiving 10-15% of the vote



Consistently reinforces Trump's 2020 election rhetoric, calling the election "rigged" and stating that the January 6th protesters were exercising their First Amendment rights

Launched his campaign for Congress following incumbent Rep. Tom Rice's (R-SC) vote to impeach President Donald Trump; Fry picked up endorsements from Trump and several conservatives activists, and prevailed in the primary 51% to 25%

Fry's campaign platform focused heavily on promoting former President Trump and criticizing Speaker Pelosi and President Biden; Fry enumerated that he would seek to promote Trump's America First Agenda by addressing threats through military dominance, lower taxes, fewer regulations, and the prevention of vaccine passports





Taught English through an exchange program in Japan for one year, after graduating from Boston University with a degree in international relations; served for 10 years in the US Navy, through which she was deployed twice to the Persian Gulf as a helicopter pilot

Attended graduate school with help from the GI bill, earning a master's degree in elder-focused health care; worked in several geriatric care facilities before joining her current private family practice

Entered politics in 2019, running for Virginia state Senate in a competitive district encompassing Virginia Beach, which she won with a margin of less than 1%; characterized her military, health, and business background as key to shaping Virginia policy

Ran for Congress in 2022 in a competitive primary for Virginia's newly-redrawn coastal district; prevailed over Jarome Bell, a Navy veteran backed by far-right figures including retired Gen. Michael Flynn, with 55% of the vote

Congressional platform covered a wide range of issues, most notably emphasizing improving services for mental health care, the elderly, and veterans

Faced incumbent Rep. Elaine Luria (D) in the general to represent Virginia's 2nd District, which shifted slightly more conservative after redistricting and was a top target by GOP strategists


